Narratives

Disaster Damage:

From June 18 to June 22, 2018, areas in South Texas were impacted by widespread rain and severe thunderstorms. The majority of rain fell the night of June 19 through the morning of June 20, leading to upwards of 18 inches of rain throughout the area. Although South Texas was in drought conditions right before this event, the area saw significant flooding. According to the National Weather Service, some of the most impacted communities were the cities of Alfred, Alice, Orange Grove, and Premont in Jim Wells County; Harlingen, Brownsville, and Los Fresnos in Cameron County; and McAllen and Mission in Hidalgo County. Local and national news reported thousands of water rescues performed throughout South Texas due to the formation of sinkholes and deep water that stalled vehicles. Additionally, at least 20,000 residents and businesses were impacted by the storm with more than 600 individuals in local shelters due to displacement—some residents saw upwards of 7 feet of water inundate their neighborhoods. On July 6, 2018, a Presidential disaster declaration, DR-4377, was declared for Cameron, Hidalgo, and Jim Wells Counties.

Recovery Needs:

The state of Texas completed the following needs assessment (the Assessment) to identify longterm needs and priorities that inform the state's use of the 2018 South Texas Floods CDBG-DR funding. This Assessment is a comprehensive set of data sources that cover multiple geographies and sectors and was completed in accordance with HUD guidelines cited in section VI.A.2.a. of HUD's Federal Register notice, 83 FR 5844 (February 9, 2018). The information focuses on the flooding impacts in the three CDBG-DR eligible counties: Cameron, Hidalgo, and Jim Wells. The Assessment was compiled using federal and state sources, including information from FEMA, HUD, the Texas Division of Emergency Management, and the Small Business Administration. This Assessment includes specific details about unmet needs within the eligible communities that relate to housing, infrastructure, and economic revitalization resulting from the 2018 South Texas Floods. The Assessment will primarily consider and address the housing unmet needs before other needs in accordance with HUD's Federal Register notice 85 FR 4681 (January 27, 2020). The Assessment will also discuss additional types of assistance that may be available to affected communities and individuals such as insurance, other federal assistance, or any other possible funding sources. Taking the above into consideration, mitigation and resiliency measures to protect against future hazards will also be examined.

Overall Progress Narrative:

Overall Narrative

All programs are active and underway. The 2018 Floods local infrastructure competition is complete. There were 13 awards for the 2018 competition with contracts expected to be executed and entered into DRGR in Q2 2023.

GLO's efforts to Affirmatively Furthering Fair Housing: To-date across all grants, GLO has completed 663 AFFH reviews of subrecipient and multifamily projects being considered for funding to determine whether projects are consistent with goals of affirmatively furthering fair housing. Within Q1 2023, GLO completed 66 such reviews.

Affordable Rental Program:

GLO awarded funds for the development of 4 affordable rental developments comprised of 216 units, of which 174 will benefit low- and moderate income households. The GLO has authorized the start of construction on one development that will start construction beginning Q2 2023 and anticipates that the other 3 developments will start construction in Q2 2023. Project delivery expenditures are related to Environmental Reviews, Underwriting reviews, and fair housing reports. The first draws for construction activities are anticipated to be received by the Affordable Rental Program in Q2 2023. While the projected and actual accomplishments for this activity are combined for the 4 developments, the required information for each is identified in the attached spreadsheet.

Homeowner Assistance/Reimbursement Programs:

During the reporting period, the Homeowner Assistance and Reimbursement Programs received 90 applications. As of the end of Q4, GLO was in the process of reviewing 77 projects for eligibility, had approved 24 Homeowner Assistance Program applications for assistance, completed construction on 71 households, had construction underway on 16 houses and approved 2 reimbursement requests. Some Projects being reviewed for eligibility may be duplicated in multiple quarter reports.

The Planning Program will take place in locations impacted by the 2018 South Texas Floods. The HUD-identified most impacted and distressed areas will see the most benefit of these planning activities, as 80 percent of planning funds will be used in studies which directly impact the HUD-identified most impacted and distressed



areas.
